Bid Description: Hiring of Three Tipper Truck

SPECIFICATION FOR HIRING OR THREE TIPPER TRUCK

1. BACKGROUND

1.1 The Sakhisizwe Local Municipality has got a mandate of constructing and maintaining the access roads under its area of jurisdiction. The service delivery model that the municipality currently utilizes is the funding thru Municipality Infrastructure Grant (MIG) and In-house project. The In-house is therefore equipped by municipality resources. Therefore, the municipality **seek to beef-up the trucks** by three tipper trucks (10m³ size) to do the hauling of gravel wearing course material from Cala landfill site to Xonxa / Macangeni access road. The reason is that the municipality is currently having one active tipper truck at its disposal and there other one was involved in accident and it is still broken done. In addition, the Municipality has been recently hit by heavy rains which left the municipality overstretched with the resources.

The Municipality is calling on for suitable Service Providers that possess the abovementioned plant to undertake the hauling of gravel material and dump the heaps along the road.

2. PROJECT LOCATION

2.1 The access road is at Xonxa /Macangceni area at ward 03. The gravel material will be taken from Cala Landfill site. The overhaul distance is 11km.

3. PROJECT DESCRIPTION

3.1 Hiring of three, 10m³ Tipper Trucks on Wet Rates over a period of 8 working days to haul gravel wearing course material from Cala Land fill site and dump the heaps along Xonxa /Macangceni Access Road in Ward 03.

4. SCOPE OF WORKS

4.1 Hauling of gravel wearing course material from Cala Landfill site to Xonxa/ Macangceni access road and dump the heaps along the road. These trucks will be loaded by the municipality machinery. The tally man will be on site to direct the dumping process and record the loads on tally sheet.

The service provider will need to consider all the necessary running cost i.e. accommodation of plant and staff, security and other related cost that will be incurred during this time of operation. Whether in the form of build-up rates or on establishment and de-establishment.

5. MINIMUM SPECIFICATIONS

5.1 GENERAL

5.1.1 The service provider must be aware that the municipality is not working during the weekends and the holidays. During the working days, the hours of operation starts at 07:45 am and knockoff at 16:30 pm from Monday to Thursday. On Friday, it is 07:45 am to 16:00 pm. Break time will only be allowed during the lunch time, which starts at 13:00 pm to 14:00 pm.

Due to the Roads Foreman and the Excavator Operator living in Elliot will need to provide a travelling time of 20 minutes to and from the site, as results, the loading will start at 08:00 am up to 16:00 pm. Therefore, the minimum working hours that is expected from the awarded service provider is 6.5 hours per day from Monday to Thursday and 6 hours on Friday, excluding the lunch break.

5.1.2 The municipality will not entertain any standing time which may be caused by rain or extreme weather conditions. If the service provider experience such, it is within its own right to reschedule or use such time for his / her benefit up until the site is conducive. The reason for the municipality to not take such risk is that, this contract is short term.
