1. PROJECT BACKGROUND

1.1 The Building Control Officer conducted inspections on the buildings which are registered on the Municipality's Asset Register in order to provide his opinion for buildings to be renovated for the financial year 2021/2022.

1.2 The property on ERF 1059, UMTATA ROAD, CALA consists of two (2) buildings which are leased by the Municipality to the ANC Xhalanga Constituency and a Non-Governmental Organisation called Sophila Sonke Home Community Based Care.

1.3 The Building selected on ERF 1059 for renovations is used by the NGO and has minor damages to it of which most of the work needed to be done is painting to internal and external walls including partially replacing and painting the ceiling.

1.4 The Constituency Building has already been renovated amongst the two buildings on ERF 1059 and the ceiling was only painted due to financial constraint but parts of the ceiling and timber branderings have been damaged and need to be replaced.
